Clients can track the delivery status of their invoices at all times and also have the option of checking invoice data against order and delivery information.

PDF (PKI) e-Invoice

This solution is a great option for companies that issue large amounts of invoices to many small clients. All invoice data (EDIFACT, CSV, I-DOC, etc.) are exported from the company's ERP system and are used to create customizable PDF invoices. In addition, there is the option of signing these invoices (PKI) and adding auditproof archiving. PDF invoices are delivered to the invoice recipient via e-mail (including receipt) or they can alternatively be downloaded from a portal using a secure link.

Additional functionalities are also available, including time-stamping, reminder management and a variety of reports designed to ensure a secure invoicing process.

The Web EDI solution tradeIT has been created to meet the needs of small and medium-sized businesses. Users rely on this online portal to manage electronic invoices, sent them to clients in the respective EDI format and archive the documents accordingly. Legal requirements for electronic invoicing

Electronic invoices must meet four requirements to be eligible for tax deductions:

- › The electronic invoice's authenticity of the origin
- › Integrity of content
- › Legibility
(humans must be able to read the content)
- › Consent by the entity receiving the service to receive electronic invoices
